Admission to 1st Semester Diploma in Engineering/ Technology, Lateral Admission to 3rd Sem. Engineering/ Technology & 1st Sem. / 1st Year Non-Engineering Courses

Diploma admission-2022 shall be conducted through ONLINE Application in SAMS portal by eligible candidates for admission into 1st Semester Diploma Courses in Engineering/ Technology, Lateral Admission of the eligible Candidates to 3rd Semester Diploma Engineering/Technology Courses, 1st Semester/ 1st year Non-Engineering for the session 2022-23.

ELIGIBILITY:

A) (i) Admission to 1st Semester of Engineering / Technology : Pass in HSC examination/ 10th standard examination conducted/ declared equivalent by BSE, Odisha.

(ii) Admission to 3rd Semester under Lateral Entry Scheme for eligible candidates: Pass in +2 Science Examination from CHSE, Odisha or its equivalent examination with PCM / +2 Vocational (2 years course) in any Engineering Trade / 2 years ITI in Engineering Trades/ COE Trades with pass in HSC examination / 10th standard examination conducted / declared equivalent by BSE, Odisha.

Age: Minimum 14 years for all courses except Mining/Drilling and Minimum 16 years for Mining/Drilling as on **01.07.2022**. No Upper Age limit.

Reservation: Reservation under different categories will be applicable for candidates, whose parents are residents/natives of Odisha only as per norms specified by Government of Odisha. Further children/ward of All India Civil Service Officers serving in the State of Odisha can avail the reservation under all categories except SC/ST.

Outside State Candidates: Outside State candidates fulfilling eligibility criteria are also eligible for:

(i) Admission to 1st Semester of 3 year Diploma Engineering Courses against 15% seats reserved for them in Private Engineering Schools & Polytechnics only.

(ii) They are also eligible to take admission under Lateral Entry provided they have prosecuted their study for the qualifying examination in an institution having approval from the competent authority after exhaustion of state merit list.

B) Admission to Non-Engineering Diploma Courses:

(i) Modern Office Management (MOM): Pass in 10+2 Examination from CHSE, Odisha or its equivalent examination in Science/ Arts/ Commerce recognized by CHSE, Odisha.

(ii) Pharmacy : A pass in 10+2 examination (science academic stream) with Physics, Chemistry and Biology or Mathematics or Any other qualification approved by Pharmacy Council of India as equivalent to the above examination,

(iii) Hotel Management & Catering Technology (HM&CT): Pass in 10+2 Examination from CHSE, Odisha or its equivalent examination in Science/ Arts/ Commerce recognized by CHSE, Odisha.

(iv) Beauty Culture (BC): Educational qualification is same as 1st Semester of Engineering/Technology course.

Age: Minimum 14 years for BC & 16 years for MOM, Pharmacy & HM&CT as on **01.07.2022**. No Upper Age limit.

N.B. 1) Reservation under different categories will be applicable as specified by Government of Odisha.

2) Candidate appearing in the qualifying examination may also apply. However he/she has to produce the said pass certificate as mentioned above) at the time of document verification (if not validated online).
